Headline - President's 2018 budget: A call to action

Today President Donald Trump sent his first full budget request to Congress. The \$4.1 trillion package proposes significant budget cuts to discretionary spending, including many research funding programs.

- USDA Agricultural Research Service cut by \$177 million (-15%)
- USDA National Institute of Food and Agriculture cut by \$116 million (-8%)
- National Science Foundation cut by \$819 million (-11%)
- Department of Energy Office of Science cut by \$919 million (-17%)
- U.S. Geological Survey cut by \$163 million (-15%)
- Science and Technology within the Environmental Protection Agency cut by \$263million (-36%)

ASA, CSSA and SSSA oppose cuts to vital federal research funding programs like those within the USDA, the National Science Foundation and the Department of Energy - Office of Science. Cuts to these programs will dramatically undermine U.S. scientists and engineers' ability to find solutions to our nation's most pressing challenges. See more budget details <u>here</u>.
